Warden MacDonald and all members of Council attended the meeting at the Essex County Civic Centre, Council Chambers. Gary McNamara attended virtually from a remote location.

6. County Warden's Welcome and Remarks

Warden MacDonald welcomed everyone to the Regular meeting and reported that the roundabout project at the intersection of County Road 42 and Manning Road was halfway finished. The east-side portion of the roundabout was nearly complete and work was to begin on the westside. To prepare for the incredible growth coming to the County, the County was spending more than \$98 million on their construction program in 2025, including \$67.6 million for capacity expansion to ensure traffic keeps moving as the population and economy expands.

Essex-Windsor EMS had launched a new AED loaner program initiative to provide for life-saving AEDs to be on hand at local events.

Essex-Windsor Solid Waste Authority had started distributing almost 120,000 green bins across Windsor and Essex County in advance of the Green Bin program's launch in October.

The Green Bin program will help residents in participating municipalities keep food waste out of their garbage and out of the regional landfill; preserving the environment and saving money.

12.1 2025 Update to Roadway Expansion Funding Model

Report number 2025-0806-FIN-R22-MR, 2025 Update to Roadway Expansion Funding Model, dated August 6, 2025, from Melissa Ryan, Director, Financial Services/Treasurer

Melissa Ryan provided Council with an overview of the Roadway Expansion Funding model, and outlined changes in cost of the program in relation to inflation, land acquisition costs, and other associated expenses.

The County's funding approach had not changed, and assumptions were based on current market realities, and would evolve as costs are refined. There were no provisions included in the model for Provincial or Federal funding (grants) as those programs were not available at the time. Funding the program to meet the needs as outlined results in a levy increase within the County's budget.

12.2 Proposed Funding Model for Essex Windsor EMS Master Plan Implementation

Report number 2025-0806-FIN-R23-MR, Proposed Funding Model for Essex Windsor EMS Master Plan Implementation, dated August 6, 2025 from Melissa Ryan, Director, Financial Services/Treasurer

Melissa Ryan provided a high-level summary proposed financing strategy for capital infrastructure projects identified in the Essex-Windsor EMS Master Plan, specifically related to the implementation of a Hub and Spoke station model. The estimated total cost for EMS station infrastructure, based on preliminary analysis from the

County's Development Charges study, was projected to be approximately \$55.6 million.

Council would be updated when further details were known, and the preliminary plan was further developed. As the details of the project unfold, additional funding opportunities would be explored. At this time a phased in levy funding plan for a portion of the costs would be included in the draft budget for 2026.

Councillor Prue questioned the rationale for having the facility located in Windsor, rather than in the County, considering the border for the County is very near the proposed location. Land cost could also be less expensive in the County.

Justin Lammers indicated that the Windsor site was chosen, due to its proximity to the new hospital site. This was the recommendation from the Strategy where the model was proposed.

12.3 County Development Charges Initiative Update and Summary of Public Feedback

Report number 2025-0806-FIN-R21-MR, County Development Charges Initiative Update and Summary of Public Feedback, dated August 6, 2025, from Melissa Ryan, Director, Financial Services/Treasurer

Melissa Ryan provided an update on the status of the County of Essex Development Charges (DC) study, and summarized the feedback received from the public meetings held across the County.

It was noted that Administration was seeking Council's guidance on which elements to include in the draft DC By-law to be presented for consideration later in 2025. Council members may provide feedback this evening or up to August 31st by email, on what they'd like to have included for consideration.

It was noted that DCs do not apply to affordable housing, which was one of the concerns that was expressed in the feedback received.

Discussion took place with regard to local municipalities and the formula used to calculate target rates.

Further discussion took place regarding the Community Improvement Plan (CIP) report which is forthcoming, and the timing of that report being presented to Council ahead of the DC by-law. Further, there was concern over outstanding studies and master plans that may reveal further municipal financial obligations not being completed ahead of the DC decision.

It was noted that discussion with the local municipalities Administrations revealed no related impact for DCs as any changes to the road ownership/responsibility would remain tied to the DCs collected for those roads; meaning the funds collected for specific roads would be passed to the receiving municipality, should a road be downloaded.

Considerable discussion took place regarding the need for DCs at the upper tier level, and options available for consideration.

Some members of Council expressed a concern about continuing the process of developing a draft by-law through the consultant, if there was a certain disinterest from Council as a whole to support it ultimately.
